Terms & Conditions for Rental Agreement for Comanche City Park, Pavilions & RV Campsites

- Any non-profit charitable organization must provide a copy of their 501(c) Exemption Letter from the Internal Revenue Service.
- Eligible non-profit organization shall pay ½ of the full price deposit and ½ rental fees.
- Local, county, state, and federal governmental entities must receive prior approval from the Comanche City Council if deposits and fees are to be waived.
- A Rental Agreement must be completed for all rentals.
- A copy of the applicant's driver license must accompany the Rental Agreement.
- If the original rental date is changed for a third time, an additional \$25.00 non-refundable deposit will be required.
- The Friends of Historic Comanche Board of Directors are exempt from all deposits and rental fees.
- No alcohol or smoking is permitted on the premises. Any violation will result in the immediate forfeiture of the deposit paid, and the individual/group will be banned from future rental of the facility.
- All garbage and trash MUST be removed and placed in the appropriate trash receptacle provided.
- Any theft or damage to the property or grounds will result in the immediate forfeiture of the deposit paid, and the individual/group will be banned from future rental of the facility.
- The City of Comanche and/or Comanche Chamber of Commerce are not liable for any accidents on the premises.
- All personal water slides, bounce houses, and/or inflatables are prohibited.
